### **QUESTIONS AND ANSWERS NO. 1**

#### ISSUED ON Dec. 4, 2017

Q1.1	Can we request to submit our tender electronically? Trying to stay green by reducing carbon emissions!
A1.1	Tenders have to be submitted in hardcopy or print form because this bid requires a bid bond and since the City is not using an electronic bidding system, the original bid bond has to be submitted with the tender.
Q1.2	Re Part A 2.2. If we find that our offer will be in excess of the specified construction ceiling, should we not bother submitting our ITT?
A1.2	The City is confident the Ceiling Price indicated in the tender, and even less than that amount, is sufficient to cover the cost of the required construction services. Bidders are encouraged to let the Contact Person know in advance if the Ceiling Price is unreasonable.
Q1.3	Are we permitted to convert the tender form to a spreadsheet format? Fonts may change.
A1.3	You may if it enables you to check your computation however you still need to print that pricing schedule page and submit the printed copy of your bid.
Q1.4	Are the areas covered in the scope required to be operational during construction?
A1.4	Access to trails in both parks will be restricted in order to accommodate construction and ensure public safety. The parking lot on Renfrew will still be in use by the public minus the area required to construct the dog park which can also be used as a site storage and staging area throughout the project. It is anticipated that the work will not impact the community
	centre/library/pool operations as well as use of the sport field and the playground in the eastern part of Renfrew Ravine Park.
