QUESTIONS AND ANSWERS NO. 1

ISSUED ON MARCH 26, 2018

Q1	I was wondering if I could get CADD drawings of the drawings package. Right now they are as pdf files. If we could get AutoCAD - CADD drawings that would assist with doing material takeoffs for estimating purposes.
A1	No, the AutoCAD drawings will not be shared by the Engineer. Pdf files of the IFT drawings have been provided and contain all necessary information for evaluation and material takeoffs.
Q2	Where we can find details of Aluminum stairs? Drawing list noted drawing # S9 for the Aluminum Stair whereas drawing S9 just includes 9m long Bridge plan & profile.
A2	Refer to Section 05 14 00 - Structural Aluminum Framing from the Landfill - Bridges and Stairs Specification (summary by C.Y Loh Associates Ltd). Specification issued through Amendment No.2 (AMD 2). Drawing list stipulates Drawing S7 pertains to the aluminum stairs, not Drawing S9.
Q3	Is the city willing to wave section GC. 75 Liquidated damages from the contract?
A3	No.
Q4	At the site walk though it was indicated a water truck for dust control would be required. Will the water truck be required to be on site for the full duration of the contract (June 14,18 - Aug 10, 2020)?
A4	It is the responsibility of the Contractor at all times, by way of water sprinkling or by other methods approved by the Engineer, to control within the Landfill any dust and flying debris resulting from the Contractors work related activities. Refer to GC.46 in the ITT.
Q5	At the site walk though it was indicated a truck scale would be required on site. Will the truck scale be required to be on site for the full duration of the contract

A5	The Contractor will be required to scale and provide weigh-slips for all incoming loads of material delivered to the Landfill. How the Contractor meets this requirement is their choice. Available options include, but are not limited to, providing an on-site scale for the Contractors exclusive use or scaling off-site.
