**RE: PART A, B, C, ETC. - MANITOBA YARDS UNDERGROUND WATER MAIN
REPLACEMENTS SUPPLEMENTAL SPECIFICATIONS AND DRAWINGS**

PLEASE ADD:

- 1. *Replace the drawing M001 & M002 dated June 14, 2018 with revised drawing M001 & M 002 dated July 16, 2018***
- 2. *Clarification: This contractor will be responsible for tree protection.***
- 3. *ADD: A Water Main Trench Detail is added to drawing M001.***
- 4. *Clarification: It is anticipated that this project will start 1st ahead of the other two projects: asphalt and concrete replacement project and the interior scope of work project. The other two projects could start after this project or concurrently with this project as long as it follows the proper sequence of work.***
- 5. *ADD: Contractor shall provide unit prices for installation 200 mm, 150 mm, 100 mm, 75 mm, 65 mm, 50 mm pipe main.***
- 6. This Contractor shall refer to M001 for all incoming water service termination point. The incoming water shall terminate as close to the existing building as possible without undermining existing building structural footing.**
- 7. This contractor shall engage a subtrade to perform a survey of the existing underground piping for the routing of the new water and fire mains using Ground Penetrating Radar (GPR) at start of this project. If GPR result shows conflict with the proposed pipe routing, contractor to notified CoV PM and consultant right away.**

8. Water meters and backflow prevention for the incoming water mains for this site is removed. Contractor to provide isolation valves and union pieces for future water meter chamber installation on the incoming Yukon and W. 70th mains. This scope of work to be provided as separate price. Refer to M001.
9. Clarification: This contractor shall apply for plumbing permit for this project.
10. This contractor shall provide thrust block and pipe restraints on the pipe main as required in accordance with MMCD documents.
11. Refer to drawing scale as noted in plan for use.

This addendum must be completed, and attached to your Tender form.
