Q2	Confirm which aggregate materials will be owner supplied for use by the contractor for this project.
A2	All granular materials shall be provided by Contractor.
Q3	Some clarity is required around schedule and working windows and substantial completion:
	• Phase 5 Culvert Extension (Feb 15 to Apr 15) = 61 calendar days. Please confirm the window is 61 days, not 35 days noted in Schedule 2 - Specifications
	• Phase 5 South Lift 1 Leachate Collector (Feb 15 to May 20) = 95 calendar days. Please confirm the window is 95 days, not 35 days noted in Schedule 2 - Specifications
	• Phase 4 North Lift 4 HGCs (Apr 15 to Jul 31) = 108 calendar days. Please confirm the window is 108 days, not 40 days noted in Schedule 2 - Specifications
	• Phase 4 North Gas Sub-Header Pipe (Oct 1 to Nov 30) = 61 calendar days. Please confirm the window is 61 days, not 25 days noted in Schedule 2 - Specifications

A3	Tenderers are required to make a clear distinction between the construction window, described as the timeframe of opportunity in which the Work shall commence and be completed, and the construction period described as the construction duration or maximum number of days in which the Contractor shall complete the work once started.
	Working outside the defined construction windows will not be permitted due to landfill operational filling requirements and other consequent projects.
	Exceeding the construction windows/timeframes could expose the Contractor to damages and additional costs associated with deep trenching.
